


Analysis of Forsythin in Forsythia

1. Forsythin

Standard Mix Forsythin (0.2 mg/mL in Methanol)

Pretreatment procedure

- Collect sample (commercially available Forsythia powder) and passed through No.
- Weigh 2g of sample and transfer into a stoppered conical flask.
- Add 25 mL of Methanol into flask.
- Close the stopper and reweigh.
- Ultrasonically treat it (power 250 W, frequency 40 kHz) for 25 minutes.
- After cooling, weigh the conical flask.
- Add Methanol to bring the final weight to the pre-reflux weight (Step d).
- Shake well and filter, then transfer 10mL into a 25mL flask.
- Add water to bring the final volume to
- Shake well and filter into a sample vial.
