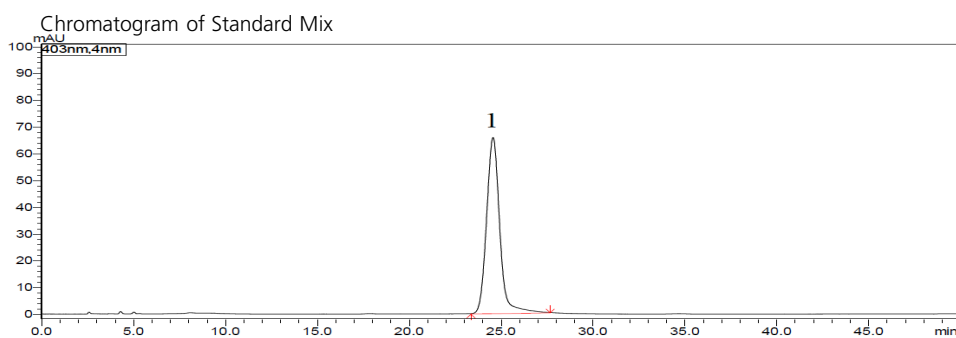

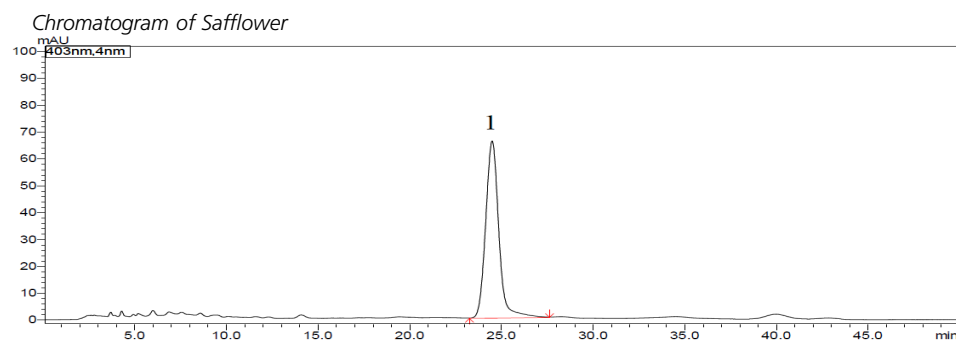


1. Hydroxysafflor yellow A

Standard Mix
Hydroxysafflor yellow A
(0.13 mg/mL 25% Methanol)

Pretreatment procedure

- Collect sample (commercially available *Safflower* powder) and passed through No. 3 sieve.
- Weigh 0.4 g of sample and transfer into a stoppered conical flask.
- Add 50 mL of 25% Methanol into flask.
- Close the stopper and reweigh.
- Ultrasonically treat it (power 300 W, frequency 50 kHz) for 40 minutes.
- After cooling, weigh the conical flask.
- Add 25% Methanol to bring the final weight to the pre-reflux weight (Step d).
- Shake well and filter into a sample vial.
